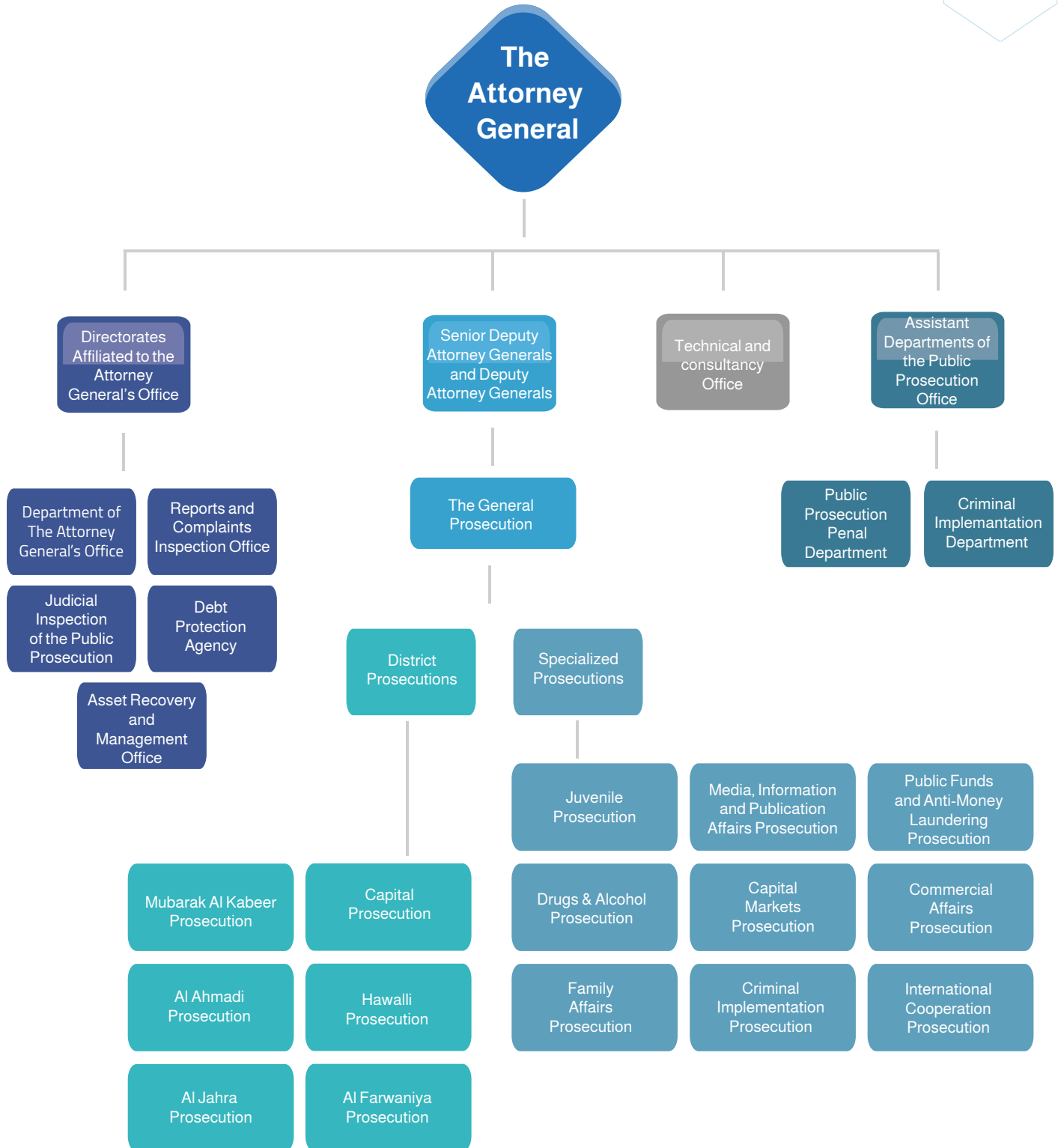

Jurisdictions of District and Specialized Prosecutions

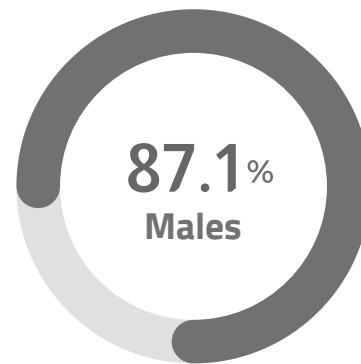
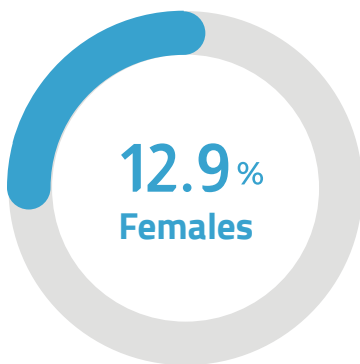

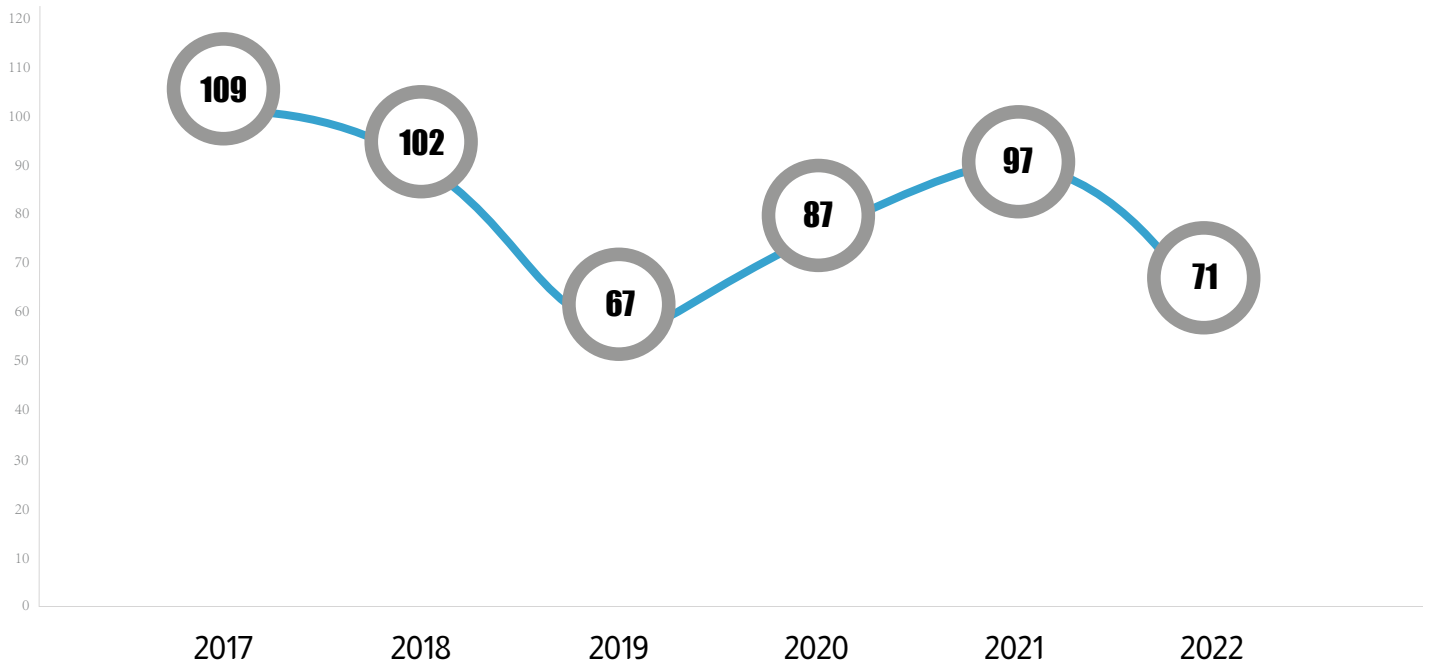

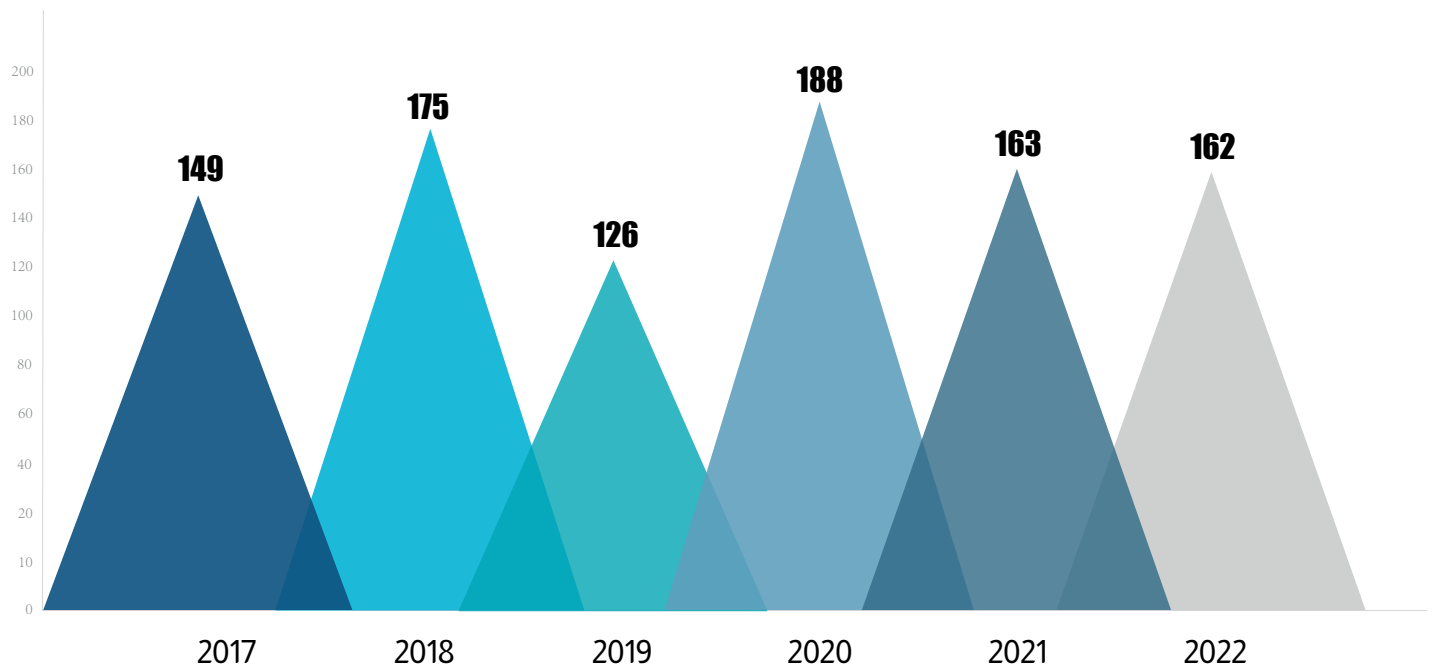

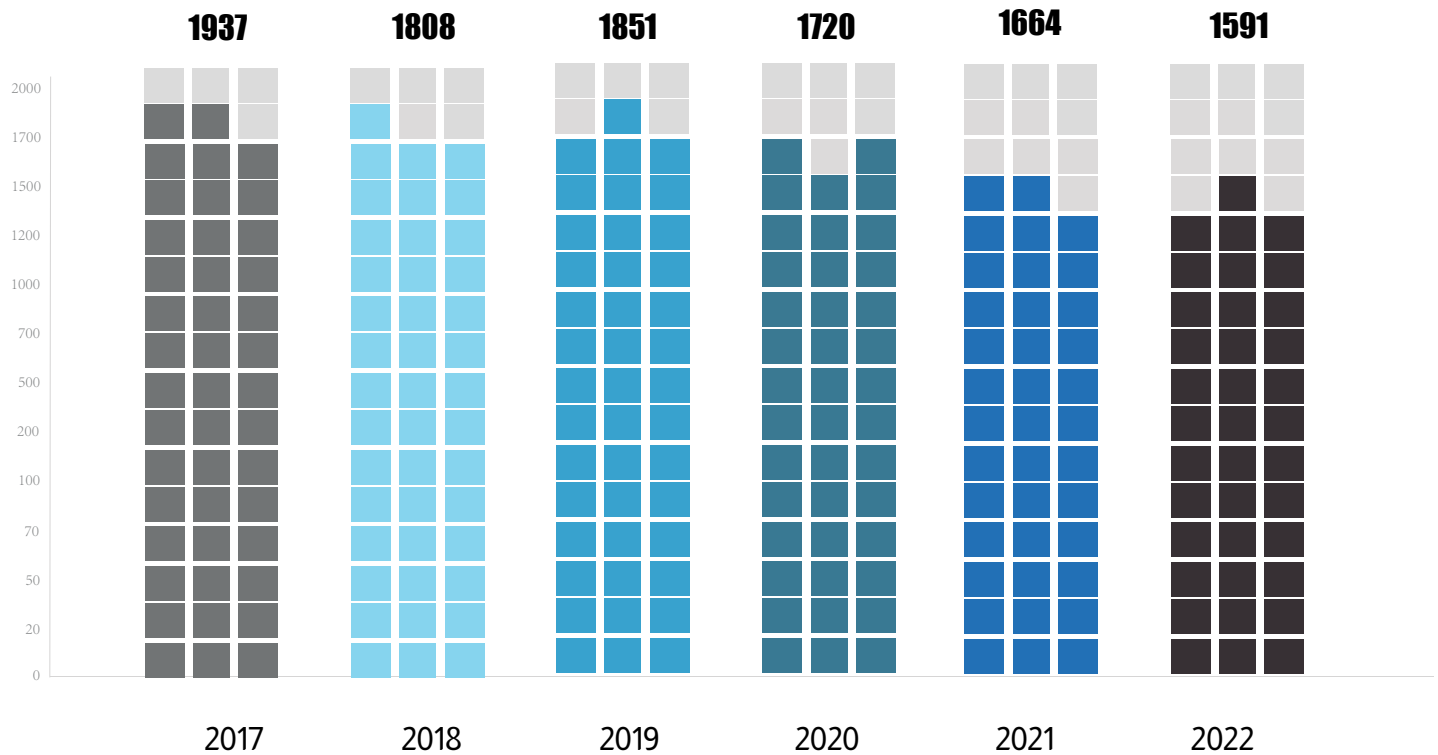

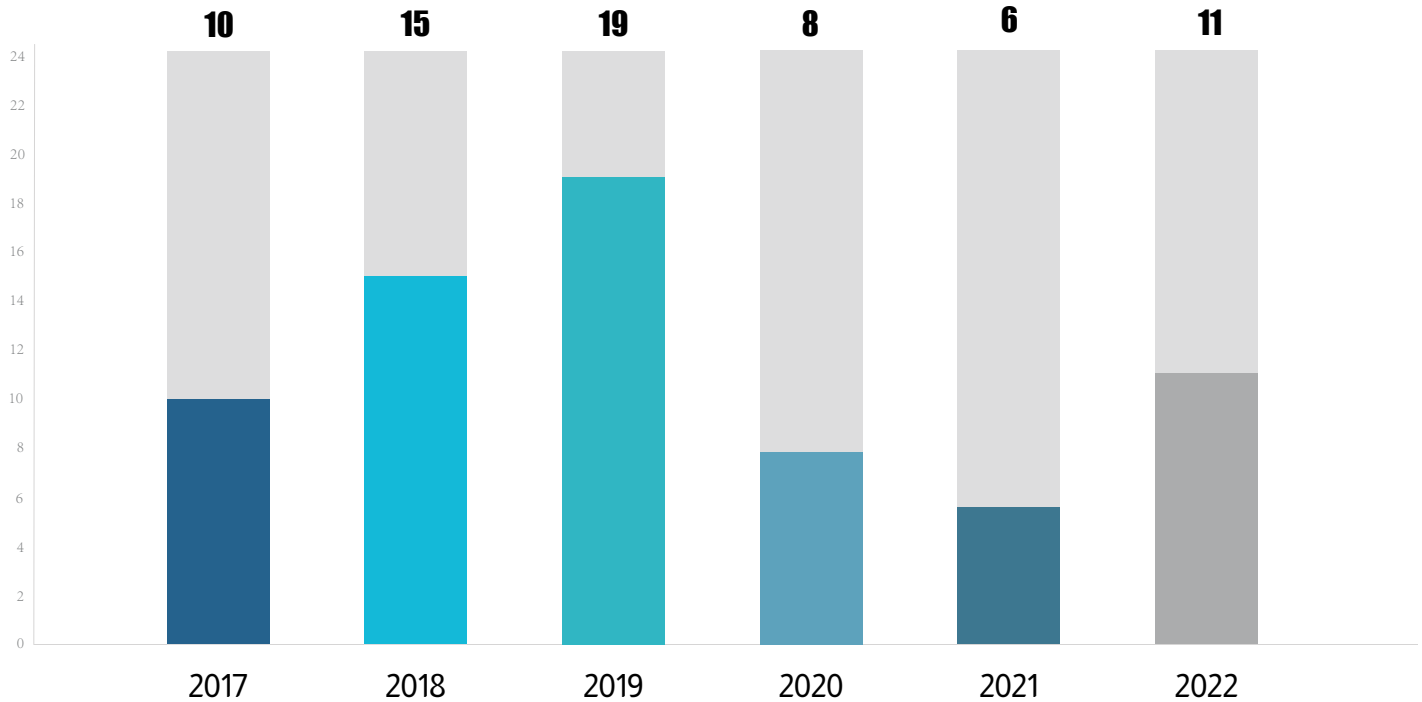

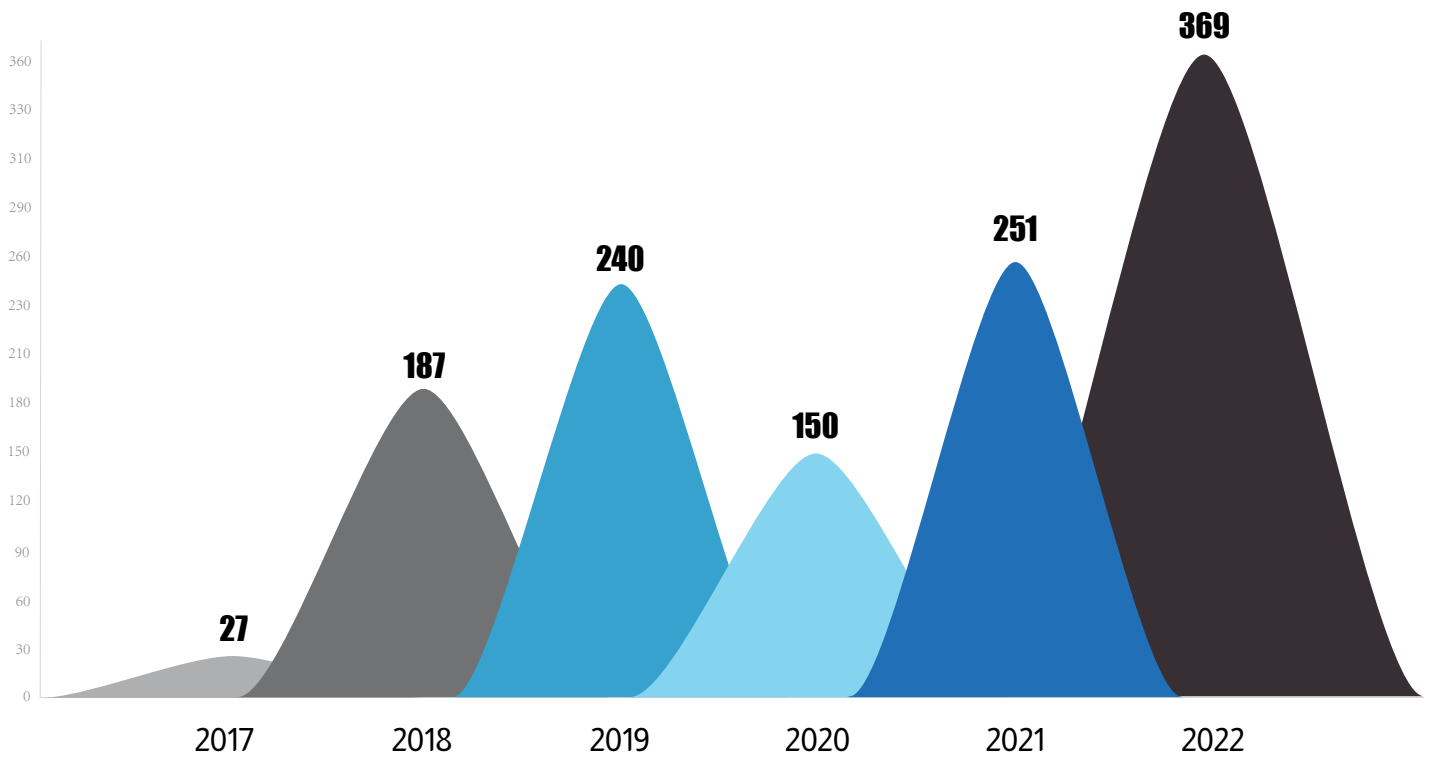

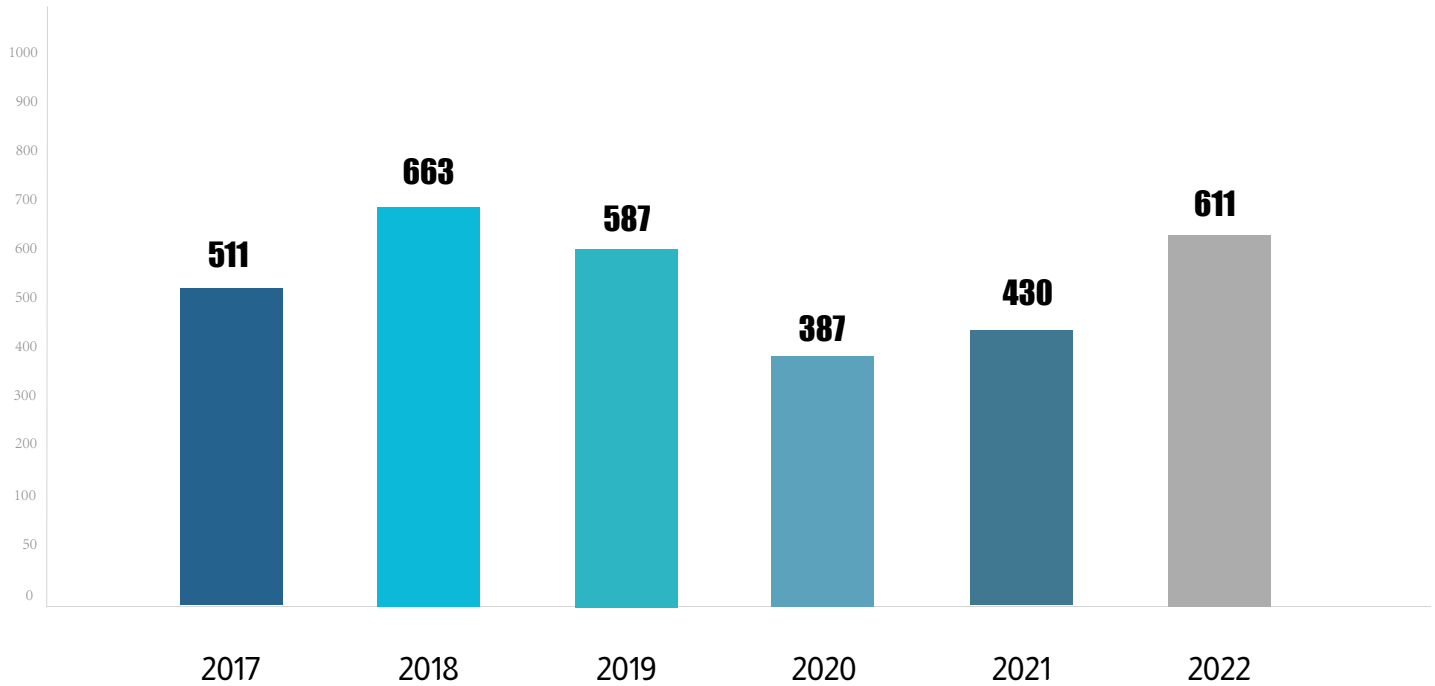

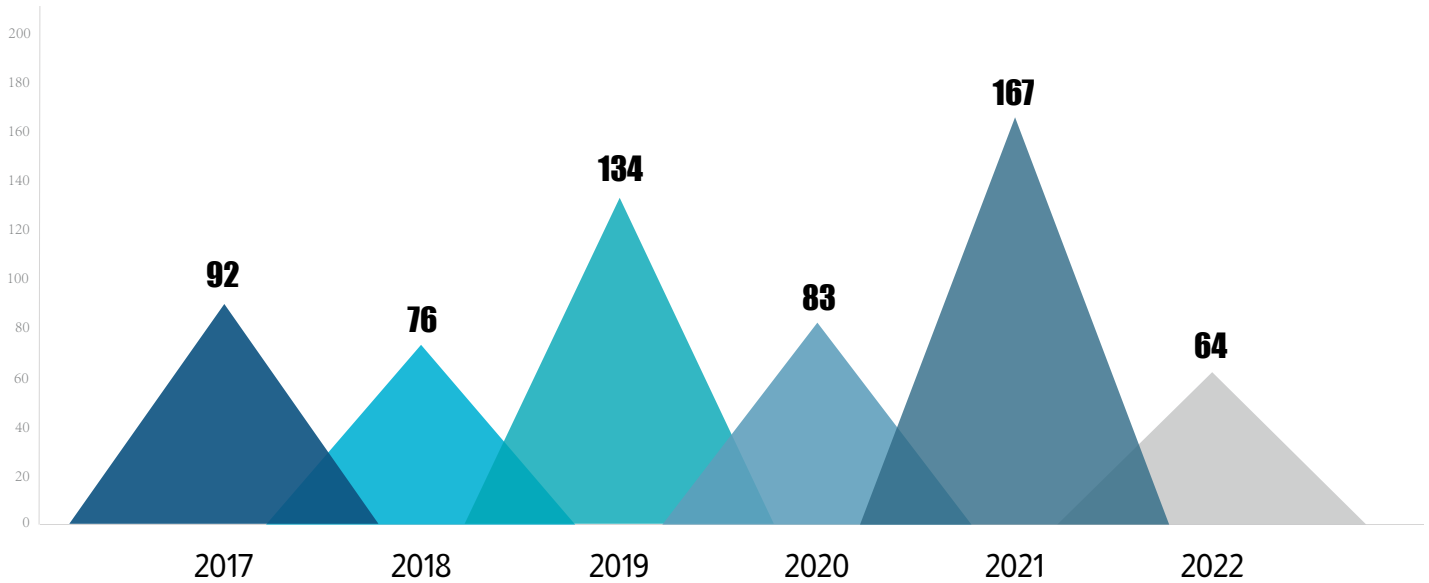

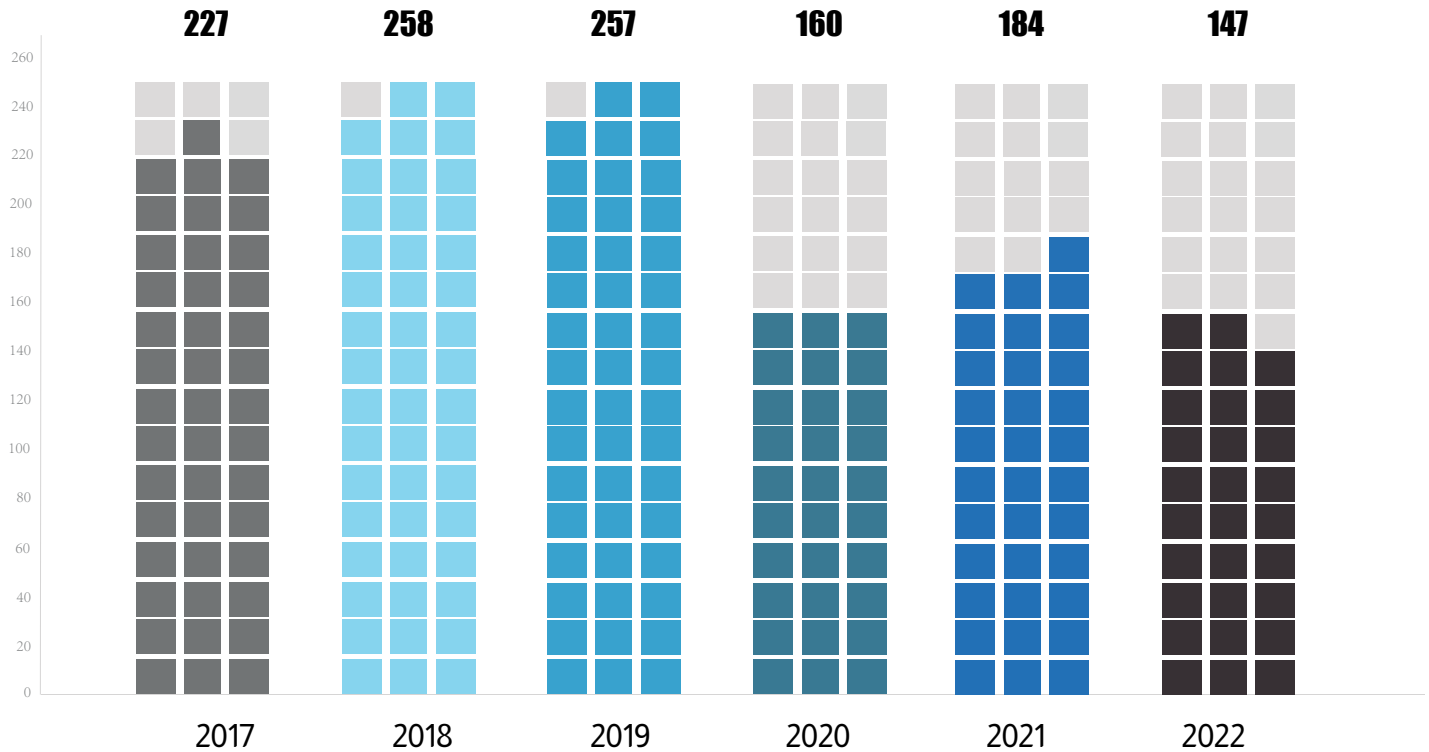

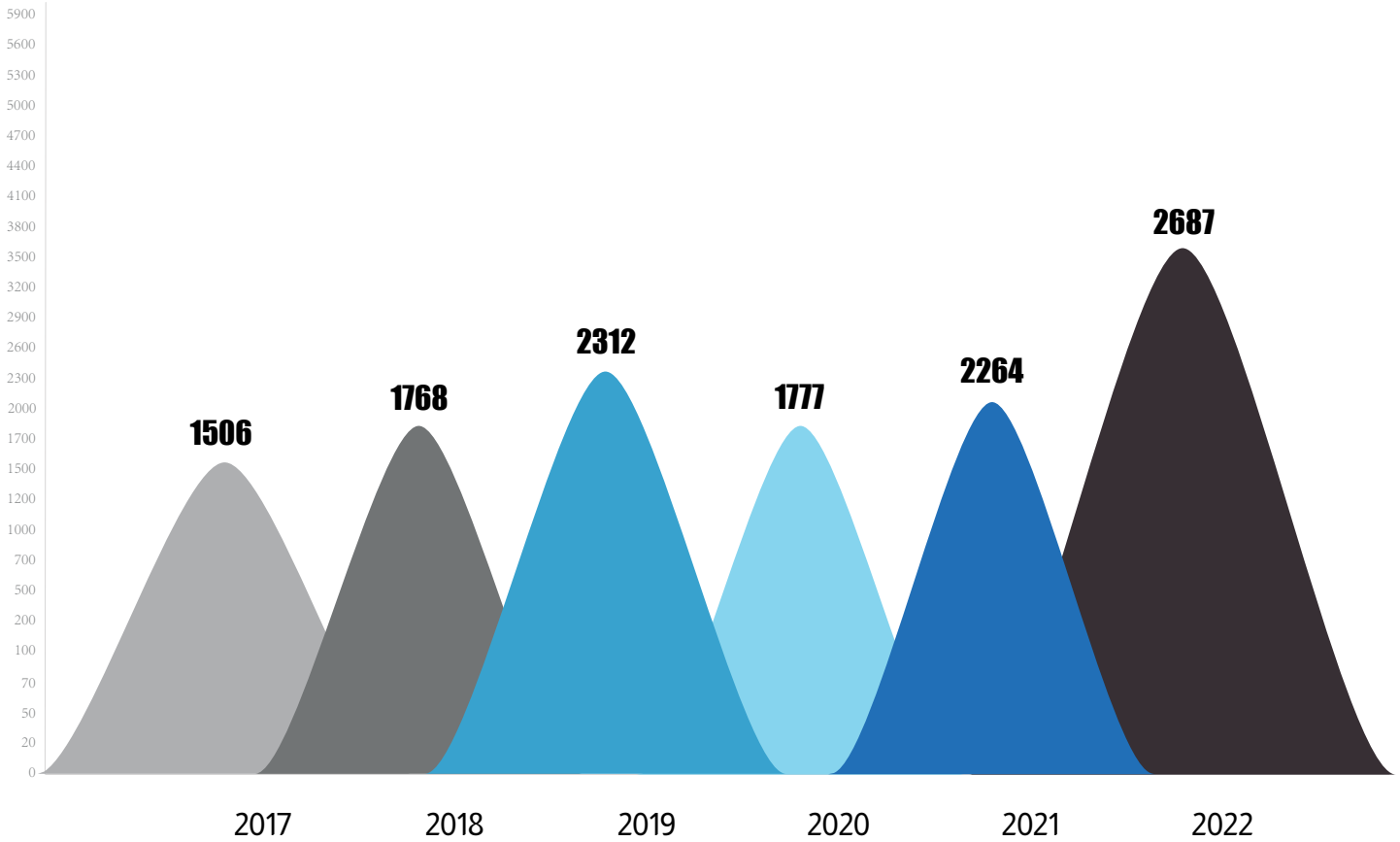

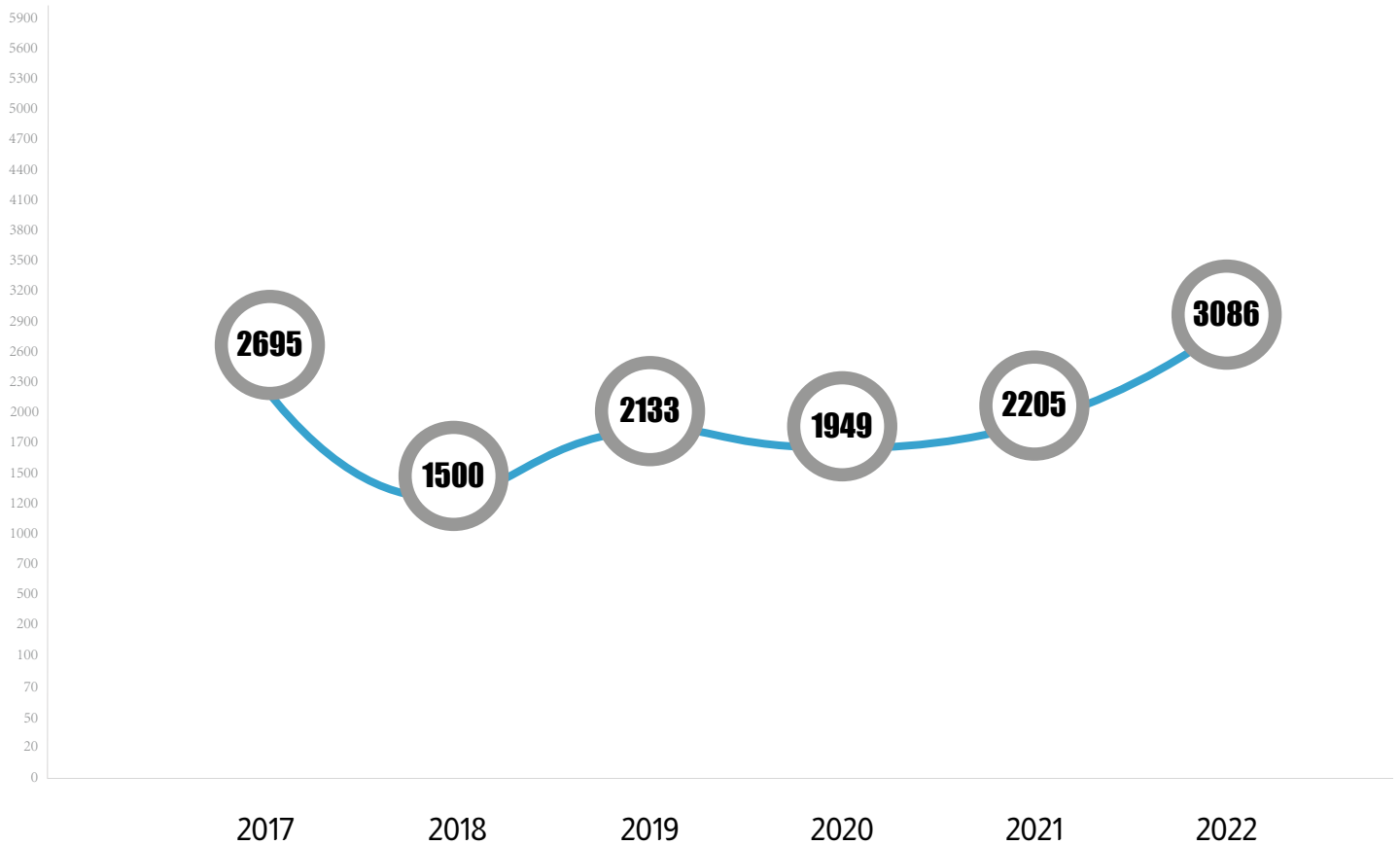

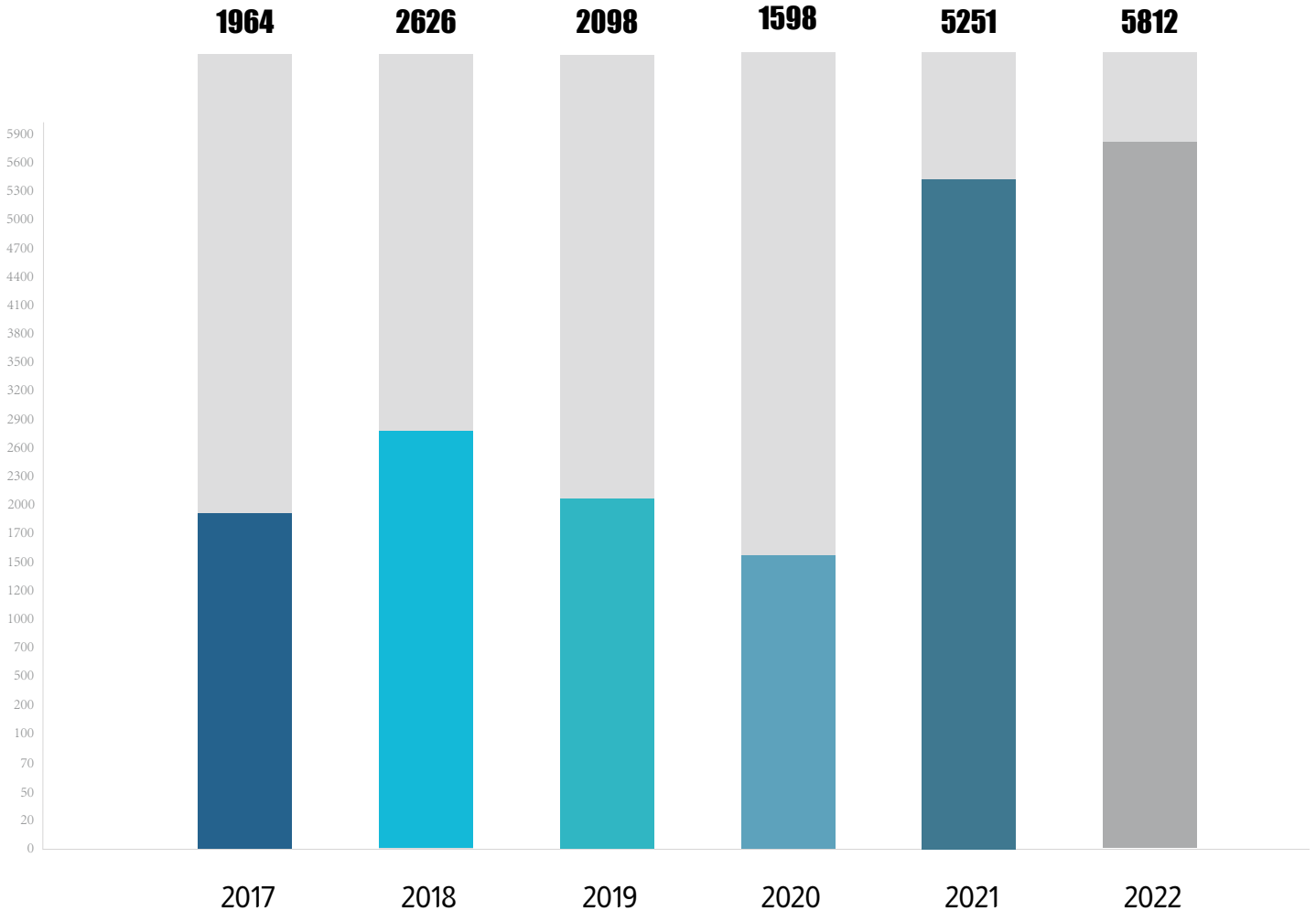

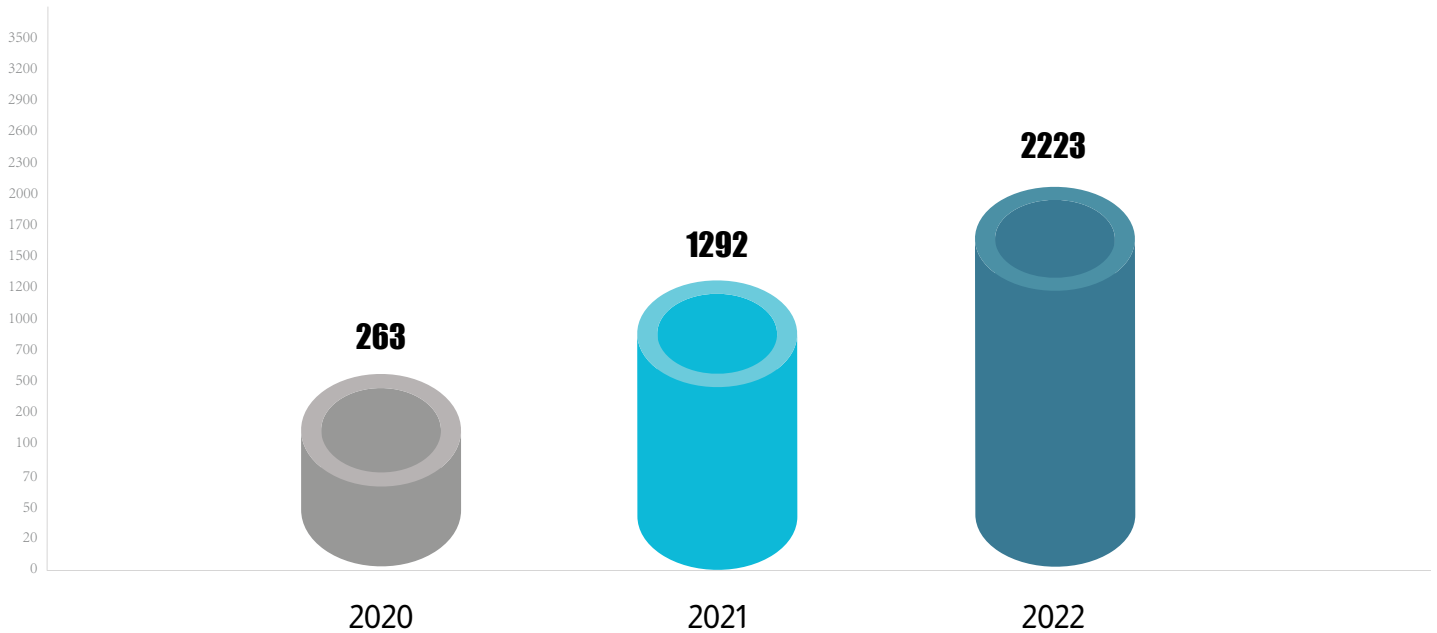

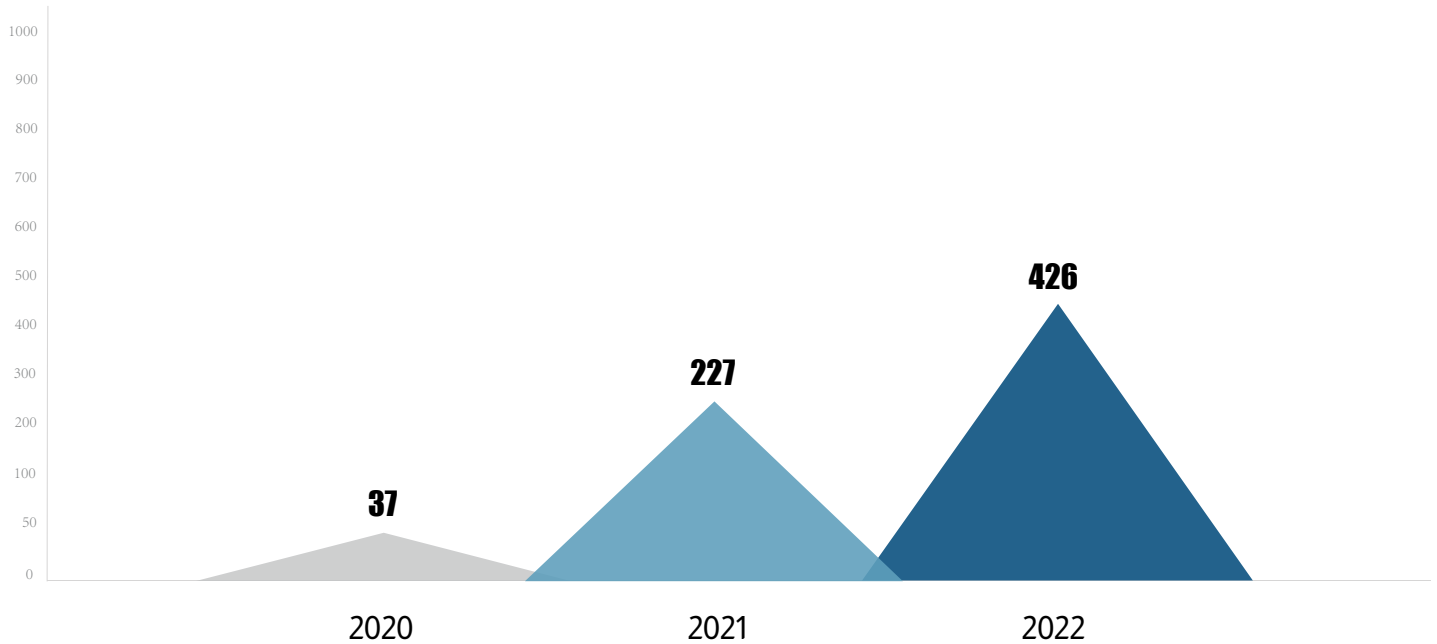

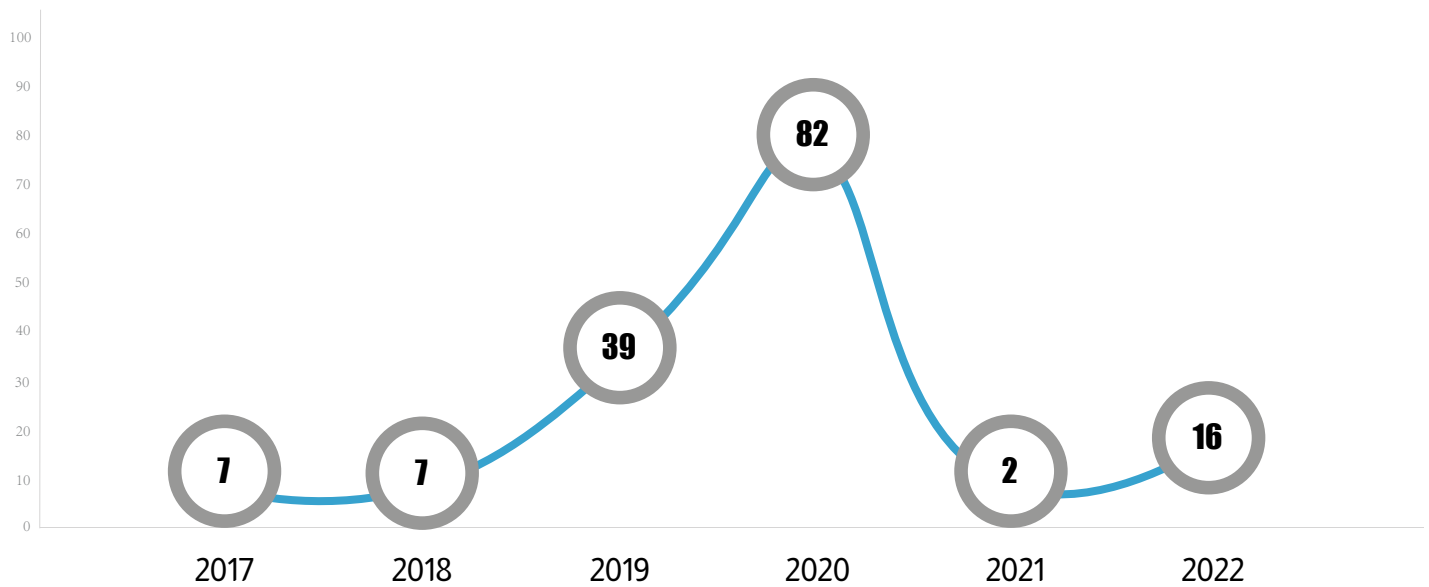

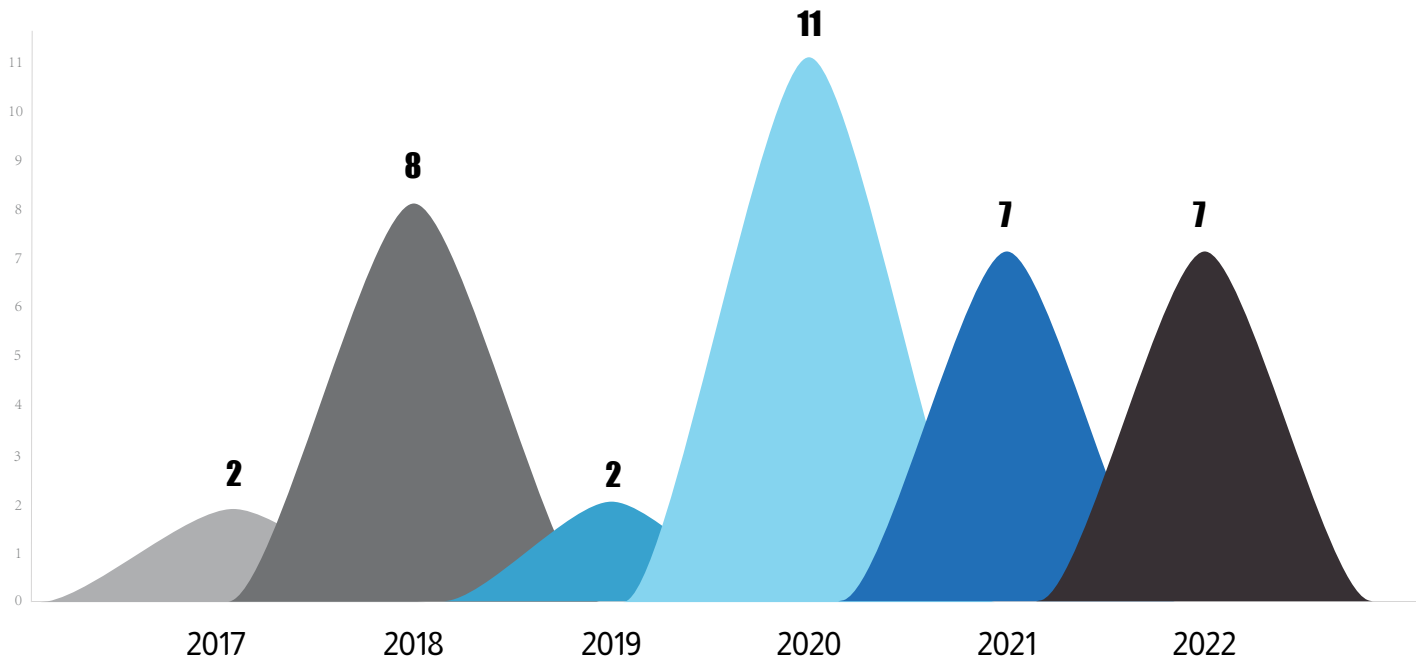

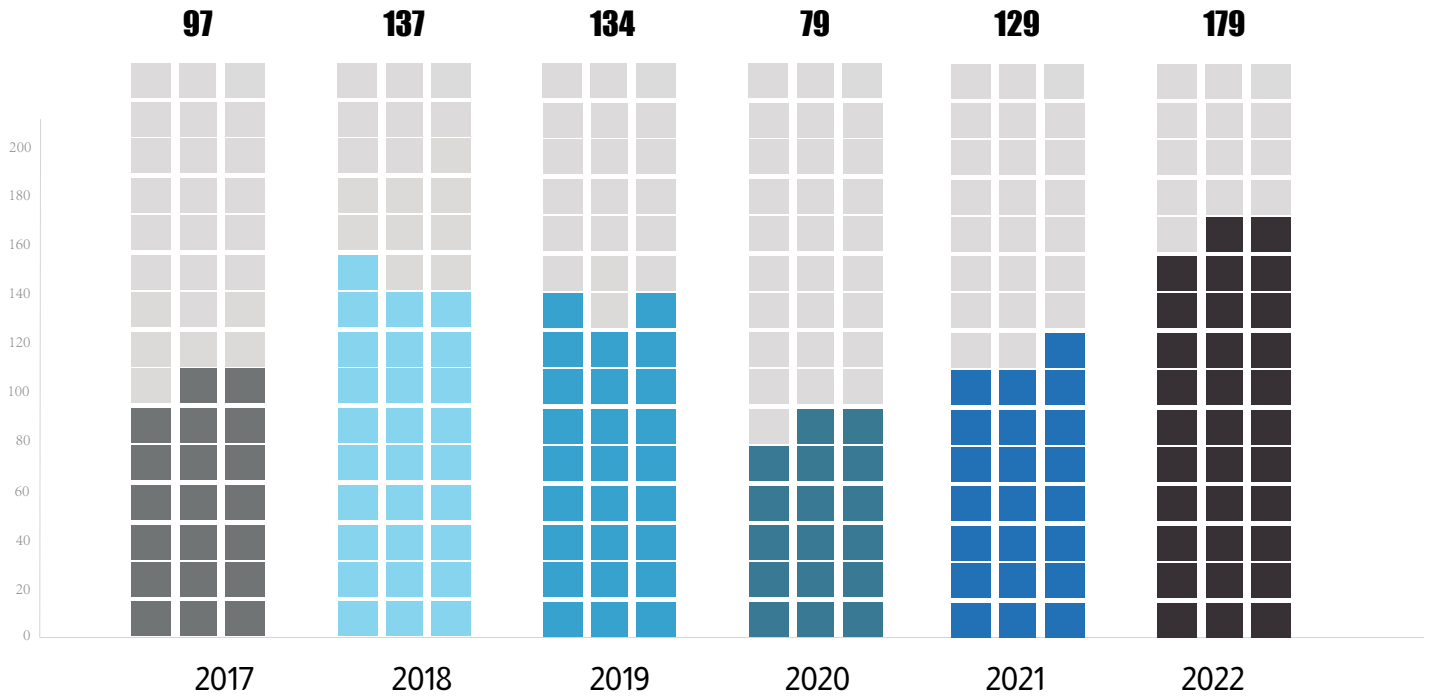

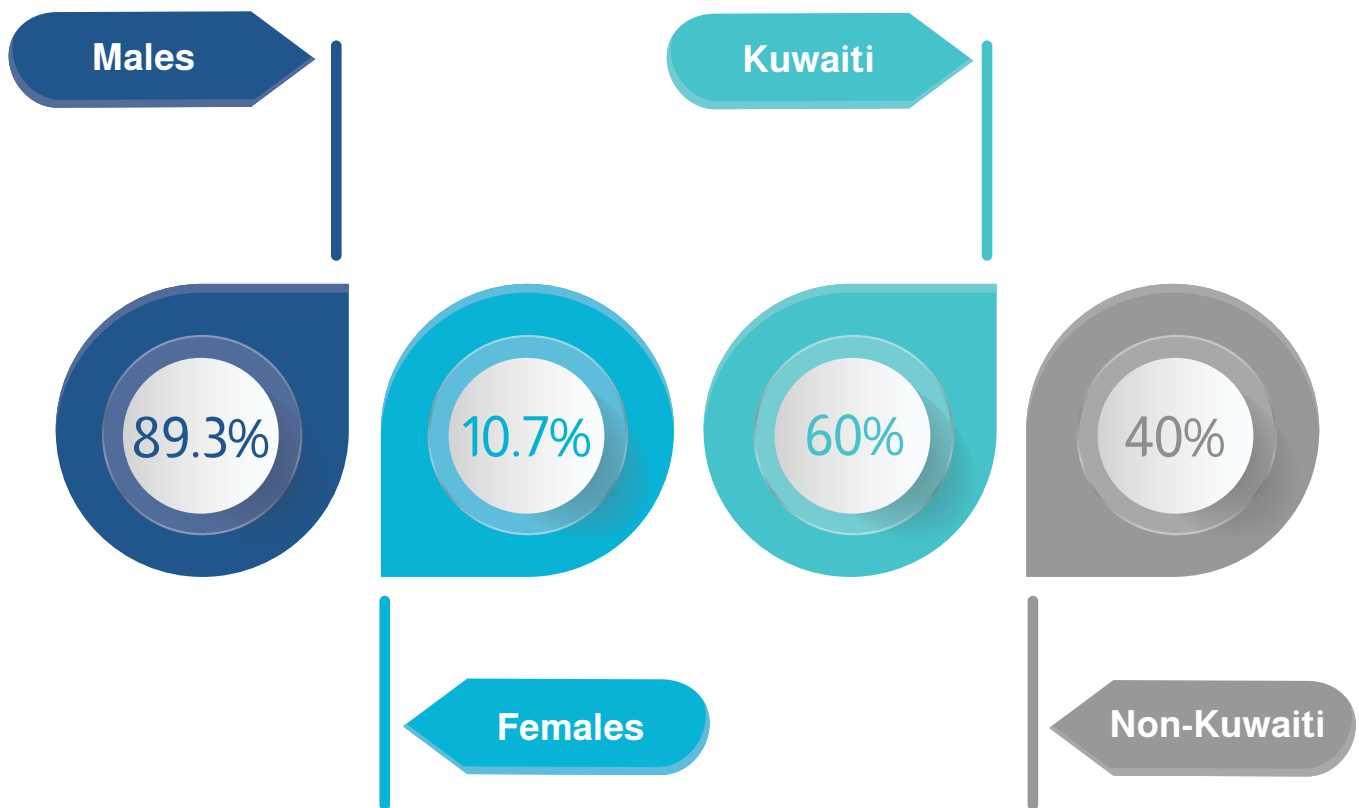

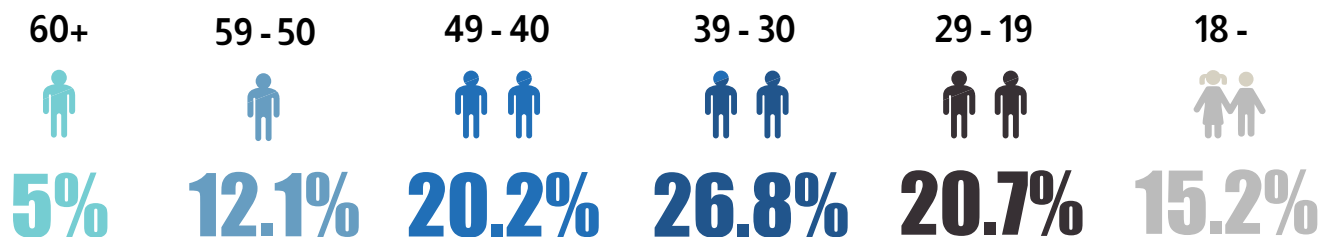

 Total number of the Accused during 2022

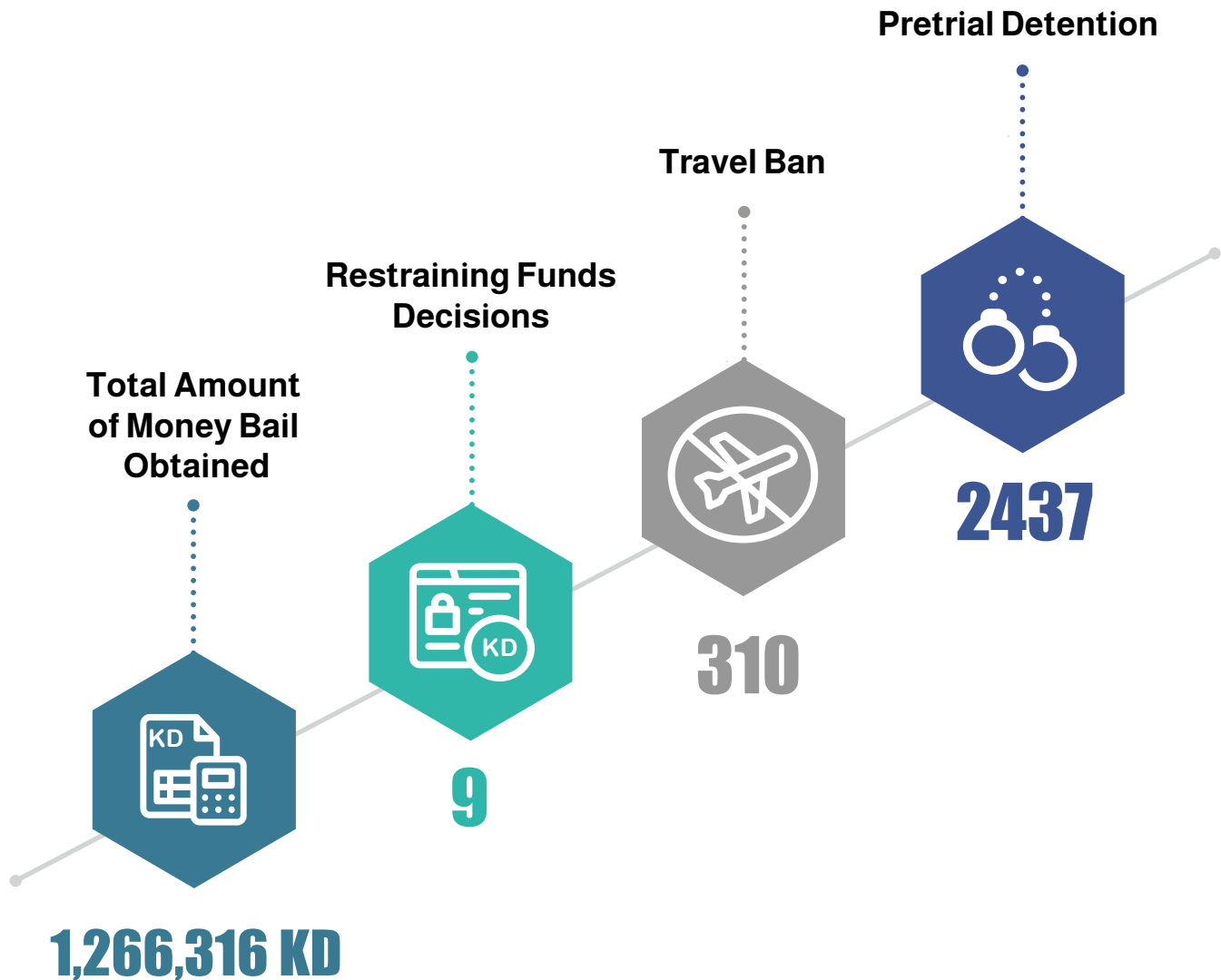

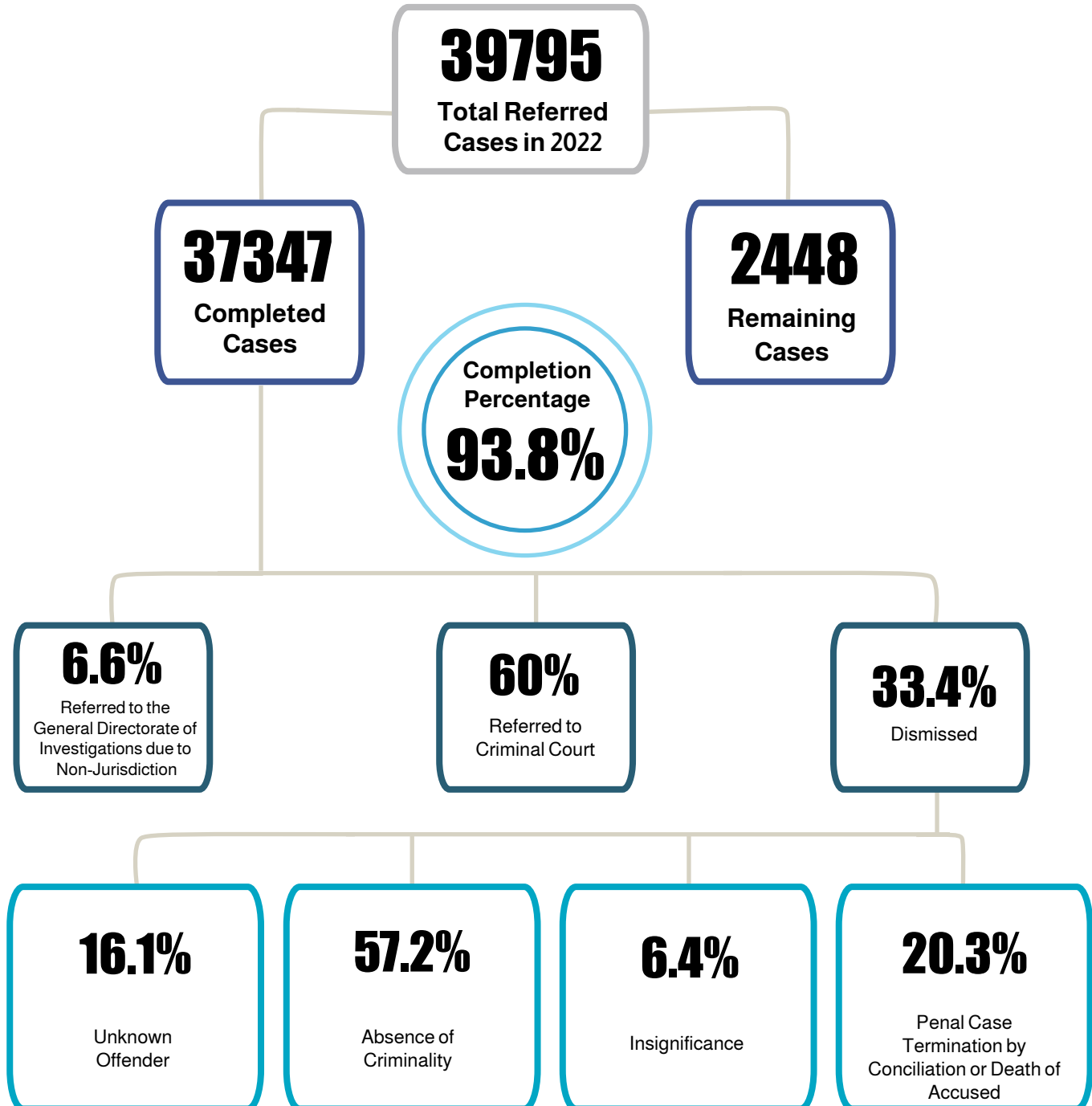
